

TWOCO PETROLEUMS LTD. THIRD QUARTER HIGHLIGHTS AND 2007 UPDATE

November 29, 2007

Calgary, Alberta – Twoco Petroleum Ltd. ("Twoco") (TSX Venture – TWO) is pleased to announce financial and operating results for the quarter ended September 30, 2007 and an update of its 2007 activities.

Twoco has filed the following documents on the System for Electronic Document Analysis and Retrieval (SEDAR):

1. Unaudited consolidated financial statements for the quarter ended September 30, 2007, together with the notes thereto; and
2. Management discussion and analysis of financial condition and results of operations for the quarter ended September 30, 2007.

Highlights of the Third Quarter 2007 include:

- Average production of 1,324 boe/d – a 42% increase from the Third Quarter 2006;
- Participation in the drilling of 3 gross (3.0 net) wells;
- Petroleum and natural gas sales revenue growth to \$3,495,911 - a 28% increase from the Third Quarter 2006;
- Cash flow from operations of \$1,787,859 (\$0.12 per share);
- Net Loss of \$436,064 (\$0.03 per share);
- Capital expenditures of \$2,084,393;
- Current land position of 118,992 gross (85,076 net) acres;
- Operating costs of \$3.50 per boe;
- Operating netback of \$18.11 per boe;
- General and administrative expenses of \$0.64 per boe; and
- Available unutilized bank line of credit of \$14,197,144 as of September 30, 2007.

Highlights of Twoco's anticipated 2007 work program and summary of operations for the year to date includes:

- Participation in the drilling of 19 gross (17.8 net) wells that have resulted in 14 gross (12.8 net) wells being cased for potential natural gas production and 5 gross (5.0 net) wells being dry and abandoned. Of the 14 gross (12.8 net) wells that were cased for potential natural gas production, 8 gross (7.8 net) wells are currently on production and 2 gross (2.0 net) wells were completed but experienced non-commercial production rates. Initial production from the remaining 4 gross (3.0 net) wells is anticipated in the fourth quarter of 2007 and the first quarter of 2008;
- Participation in the drilling of 1 additional well for the balance of 2007;

- Current production of 1,500 boe per day; and estimated current additional production capability of 600 boe per day.
- Recycle ratio of 2.3.
- As at today's date, pursuant to its Normal Course Issuer Bids, since January 1, 2007, Twoco has acquired a total of 131,200 common shares at prices ranging from \$3.12 to \$4.35 per share. Up to October 16, 2008, under the terms of the current Normal Course Issuer Bid, Twoco is authorized to acquire up to an aggregate of 750,000 of its common shares representing approximately 5% of its issued and outstanding common shares.

Twoco is an oil and gas company engaged in the exploration for, and the acquisition, development and production of, oil and natural gas reserves primarily in the Province of Alberta. Twoco has 15,153,606 common shares issued and outstanding as at today's date.

In this news release the calculation of barrels of oil equivalent (boe) is calculated at a conversion rate of 6,000 cubic feet (Mcf) of natural gas for one barrel (Bbl) of oil based on an energy equivalency conversion method. Boes may be misleading particularly if used in isolation. A boe conversion ratio of 6 Mcf: 1Bbl is based on an energy equivalency conversion method primarily applicable to the burner tip and does not represent a value equivalency at the wellhead.
